4-methoxy-5,7-dinitroindolinyl-D-aspartate trifluoroacetate

Water-soluble, stable at neutral pH, and pharmacologically inactive at neuronal glutamate receptors (up to mM concentrations).

CAUTION – This product is light sensitive, and we recommend that the solid material and any solutions obtained are protected from light. Soluble in water up to 50 mM, Phosphate buffered saline to 80 mM, Ethanol to 0.1 M

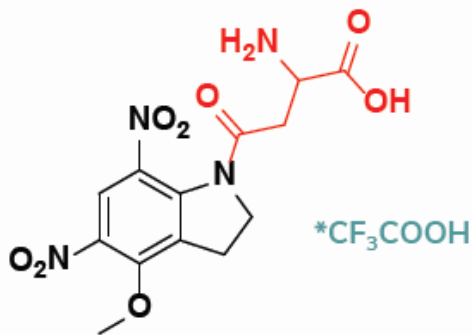

HANDLING PRECAUTIONS

Please refer to the safety data sheet. Use in a chemical fume hood, with air supplied by an independent system. Avoid inhalation, contact with eyes, skin and clothing. STABILITY AND SOLUBILITY ADVICE:

Sonication or gentle warming (45-60 °C) accelerates dissolution

We can only offer a general guide as information on product stability, especially in solution, has sporadically been reported. Our general recommendations are:

SOLID: For extended periods of time store in tightly sealed vials, under dry conditions at -20°C-0°C. The product can be stored for up to 6 months from date of manufacture.

SOLUTION: We recommend that stock solutions, once prepared, are stored frozen in tightly sealed vials at -20°C or below and used within 1 month. Whenever possible solutions should be prepared and used immediately.

STORAGE AND DISPOSAL

Store in the original closed container. Avoid direct light.
